Development Economics

Aims & Objectives Top

What is development? What is involved in the development process of a country? What is the role of the government? What is the role of the private sector? This module introduces students to economic development, by giving an overview of domestic and international topics relevant to developing nations. We will not focus on theory, but rather apply what we you have learned from microeconomics and macroeconomics to look at the experience of developing nations.

At the end of this module you should be able to understand what is involved in answering the questions such as:

- (1) Will India Ever Grow Faster Than China?
- (2) Why isn't Africa growing as Fast as China?
- (3) Is it better for Brazil to grow or redistribute income in order to reduce poverty?
- (4) Is the population growth in India compatible with high economic growth? And if not, should India implement a one child policy as China did?
- (5) Should the Indian government invest more in schooling?
- (6) As the population of the world increases can we continue feeding the world? How dos this answer depend on the environment?
- (7) Could the Financial Crisis of 2008 occur in China or India?
- (8) Is globalization bad for China, India or Africa?

Teaching Modes <u>Top</u>

There will no lecture notes. However I will follow "Economics of Development" (10th Ed) by Todaro and Smith closely for the concepts and theory. These are also well covered in two other books "Economic Development in Asia" and "The Development Economics Reader". I will add details with articles which I will provide as needed. Lectures will be webcasted, though I hope you will not use this as an excuse to skip coming to lectures, as your participation in lectures is essential for the smooth working of the lecture. I have posted last semester's slides in the workbin (they are similar to the slides I will use this semester) and I will post the new slides online after the lecture. The schedule should also give you a good idea of what we will cover each week.

In tutorials we will discuss articles which I will post, Wednesdays. Each tutorial session will be divided into 5 groups of 4 to 6 students. Each group will take turns in presenting and discussing the articles, according to the following schedule. One group is assigned to present the main points of the articles and then writting a summary in a BLOG while another group will be assigned to discuss/comment on the presentation in class and then comment on the BLOG post.

Students also have to sign up for a project which students can find under PROJECT in IVLE.

Practical Work Top

The objective of this project is to have students think on how to apply the knowledge they have acquired in this module outside the classroom and to practice writing in economics. To achieve this I ask you to prepare a proposal to apply to the Young Social Entrepreneurs Program with the Singapore International Foundation (http://www.sif.org.sg/programmes/8/young-social-entrepreneurs.html) (NOTE: It usually opens in May)

I. GROUPS - Due 27th of January

This is a group project. Please enroll on IVLE, under project to a group opening. **ALL groups must be between 2 and 4 people (ONLY - NO EXCEPTIONS!)**. If you cannot find a partner, please post on the forum. You can team up with anyone taking this module (Even those in a different tutorial group).

GRADES: Those who fail to register for a group will get a zero for the whole project!

II. PART 1 OF PROJECT - Due 17th of February

In part 1 I will ask you to think of a problem a developing country faces and how you can solve it.

- (1) Write or Add 250-500 word to a Wikipedia entry about a particular problem a developing country faces.
- (2) Write or Add 250-500 word to a Wikipedia entry about a NGO/Social Enterprise

GRADES: you must submit through IVLE (under PROJECT submissions) the preview of the changes you have made on Wikipedia (as a pdf file) in order to get credit for this part. The grading will follow Wikipedia criteria (it must be factual and have citations). Points will be awarded if you provide data illustrating your case.

III. PART 2 OF PROJECT - Due 30th of March

Submit a 1000-1500 word paper on what a NGO or a Social Enterprise can do solve the problem you described in PART 1 (It is not compulsary that you cover what you discussed in PART 1 but it will help you save time). This is the analytical part. It involves understanding what are the sources of the problem, understanding incentives people have and understanding what you can do to change those incentives.

GRADES: It will be grade it based on the same standards as those of the Singapore International Forum.

Assessment Top

20% - Tutorial Participation

Tutorial Participation is based on presence in tutorials, presentation, blog post, discussion and comment on blog post. In the presentation, I am looking at students' capacity to synthesise the reading and relate them to the material covered in lectures. For the group that is discussing the article I am looking for them to ask questions which can lead to a discussion (wide/somewhat vague questions are ok). In the blog post I am looking for a unified text that presents all the readings in the tutorials. For the groups discussing the blog post I am looking for them to help the presenting group with their writing.

20% - Project

PART 1: 250-500 words (each) Wikipedia entry, describing problem in a developing country AND a second entry describing the activities of a NGO in a developing country; (due 17th of February)

PART 2: 1000-1500 words write-up of an idea for a social enterprise. (due: 30th of March)
